These above are hereinafter jointly referred to as "TRUSTEE" (which expression shall unless executed by our repugnant to the context be deemed to include the trustee our trustees for the time being of these present and their successors in office) of the other part hereby declare and state as follows:-

1. WHEREAS the settlor of the trust keeping in view the ideals out of his philanthropic and charitable consideration have decided to establishment of public charitable trust for the advancement of education by setting up training and professional institutions for providing professional and technical education and to set up institutions to provide knowledge in the field of different kind of technical education and training and to provide financial assistance to the poor and needy people of the society of all caste and creed and for any other cause of general public utility.
2. AND WHEREAS, with a view to and for the purpose of constituting the trust permanently as an irrevocable public charitable trust, it is considered desirable that a trust should be made in the manner set out hereunder.
3. AND WHEREAS, donations amounting to rupees 51,000/- (fifty - one thousand) only in cash contributed by the settlor for the above purpose and for the fund are being and will be contributed and added to the trust fund.
4. AND WHEREAS, the settlor hereby declare that the said trust fund and all further funds settlements, donations and contributions in any shape of form to the said fund from



- i) To bring publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- j) To function as a Non-communal Trust and as a secular organization.
- k) To establish centres for employment generation .
- l) To acquire and maintain the movable and immovable properties for achieving the said objects.
- m) To advance any other objects of general public utilities.
- n) To confer title on eminent personality in the field of Science, Education and Literature etc.
- o) To establish the colleges to impart education in the area of higher education especially the emerging field like Electronics, Bio – Technology and other allied fields.
- p) To provide motor binding, welding, fabrication, screen printing for their economical development and self employment

**4. BOARD OF TRUSTEE:-** The management and control of the trust and the trust property shall vest in the board of trustees. The Board of trustees shall comprise of not less than **Three** not more than **Seven** trustees including settlor. The following will be the first and life Trustee:-

1. Kaushal Kishore
2. Nagendra Ray alias Nagendra Kumar Rahi
3. Santosh Raushan
4. Raja Kumar

**5.** One third of the trustees our as near there to as possible amongst eminent persons or selected amongst the life/ordinary members shall retire voluntarily or by loss keeping in the view of the length office or the end of every five years, but shall be eligible for re-nomination and selection. The settlor and the life trustees shall never retire unless the desire so.

**11. POWER TO SELL THE IMMOVABLE**

**PROPERTY AND MANAGE:-** The trustees shall not to sell or assign any movable or immovable property or in particles and either with or without and special or other stipulations as to the evidence or commencement of title or otherwise and rescind or very and contract for the sale and resell without being made answerable for the loss occasioned hereby and for purposes aforesaid or any of them to execute and do all such assurances act deeds and things as they shall think fit and by and out of the monies which shall arise from any such sale or otherwise in or about the execution of any of the trusts or powers of these presents and shall stand possessed of the residue of the said monies and also of the rent and profits of the said premises or of the unsold part thereof for the time being upon such trust and subject to such powers, provisions, agreements and declaration as are herein declared. Provided always that the trustees shall manage any immovable property or properties for the time being forming part of the trust fund in such manner as they shall think fit with full power to make improvements, repairs or alterations of any

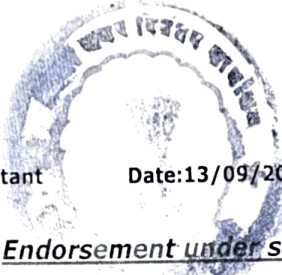
